### Thought for Today

#### ➤ From the MD's Desk:

Dear Friends,

The problem of the dry lake has been vexing us for some time. The outflow tract was leaking and this was rebuilt a few months ago. This had no significant impact on retaining water in the lake. Two weeks ago a 'lake expert' - Mr Arbind Gupta - introduced by Mrs Vathsala, visited Suvidha and inspected the lake. His observations and suggestions are as follows:



- The lack of inflow because the water source is blocked outside suvidha boundaries is a problem.
- 
- To optimize water inflow we could cut small channels around the lake and let the rainwater flow into the lake rather than flow around it.
- 
- make the southern part of the lake a little deeper
- 
- to reduce seepage of water - this is the most significant step - cover the bed with clay and compact it.

A rough estimate for this work is eight to ten lakhs. When the finances permit, these steps will be considered.

Mr Jaisim has suggested that we build check dams in the existing water channels using boulders that are in the village. This can be done at very little cost and this will be undertaken soon.

Another important issue is the discontent among some residents about the rules that we have collectively laid down in the RVM. This has to do with maintaining 'uniformity' in the landscaping and the exteriors of cottages. This came about because this 'uniformity' ensures some standards. Some

residents want freedom to do the landscaping as they wish. Lack of this is seen as infringement of their rights. Others want changes like putting up glass shutters, change doors etc that change the appearance of the cottages. Without these, they feel that their safety is compromised.

The rules in the RVM are laid down by the SH. The management is making sure the rules are followed. A process, as outlined below is in place and is being followed.

- A written request for the changes sought is to be submitted to the office.
- This will be scrutinized by the technical committee if technical issues are involved
- The board will then examine the issues involved as to whether the requested changes fall within the provisions of the RVM.
- If the answer is 'yes' to both the technical and RVM provision aspects, the requested change is allowed.
- If the matter involves landscaping issues, the SLC examines the request and takes a decision.
- If the matter involves maintenance issues, the resident directors and MD collectively take a decision.

When a request is denied, accusations of favoritism fly thick and high. Past transgressions are quoted vehemently. Decisions of the board are severely criticized. the language used to express this in verbal communication and sometimes even in writing, has been uncivil! If the rules are unacceptable to a majority, the RVM has to be changed in a AGM.

Should we not respect democratic functioning?

Should we not follow process based decisions rather than ad hoc individual decisions?

Why are we finding it so difficult to accept democratic decisions with grace?

In the evening of life, why should there be such egoistic approach to issues?

Why are we working actively towards factionalism?

Why can't there be some give and take, some friendly banter and camaraderie?

The way we are going, while we may attain financial stability, the vision of a retirement community where residents live in peace and harmony with good financial, physical and emotional health is a pipe dream.

In spite of the best efforts made by us to improve communication, have collective decisions through email exchanges and 'open houses' and showing good results in the form of improving ambiance, providing facilities and a vastly improved financial status, the strife in Suvidha continues. the unhappiness continues - at least in some quarters. Sadly there are some who put their personal egos and agendas ahead of Suvidha's good. It is for the 'silent' majority to become vocal. Or, if you feel that the present style of management needs a change, please let us know. If you do not respond with your views in large numbers, a small minority of SH will hijack Suvidha.

### ➤ 12-04-2015 : Talk on Patanjali's Yogasutras – Session 1

#### ➤ **Suvidha On The Move :**

During the month, the following developments have taken place.

- **Office Extension:** Office extension is on the way in order to improve the ambience at the SUVIDHA Office and give some relief to the office staff from frequent disturbances whenever a visitor enters the office. The office extension is envisaged to have a separate chambers for MD, Manager in charge, Reception and a Board Room. These chambers will have state of the art technological innovations like Wi-Fi connectivity, networking, video-conferencing and lap-top presentation facility. It is also envisaged to have an air-conditioning facility. The entry to this floor will be from the western road side which will be very close to the proposed new car park area.
- **New Cards Table and Chairs :** Substantial donation by Mr. Rajashekhar [#100] towards acquiring a brand new cards table with chairs has brought cheers to the SUVIDHA residents who are fond of the game. The facility will be provided at the commercial hall situated to the left of the main door as we enter the club house. It is planned to cordon off the facility with a proper partition with a door.
- **Composting :** Mr. Rama Subbarao has designed the weed shredding area to house the shredding unit in a 12' x 12' x 10' shed with mesh covering on three sides. In front of the shredding area there will be a shredded recovery area for formulation of the compost. There will be three compost stacks of size 4 x 3 x 2.5 feet each with a wire mesh top.. These structures will come up by the side of the present STP plant.
- **Name Boards :** Now the new sign boards in the Club house guide the visitors to the desired location. It is envisaged to put up some more sign boards with a different colour combination in the administration floor. Thanks to all the respondents to our call to suggest suitable names.
- **Open House :** It was held on Sunday the 5<sup>th</sup> April 2015 and this time there was a good attendance and the residents participated in discussion fruitfully. The MD welcomed the gathering and started with a presentation, the link for which is given below:

He explained that focus for the last 16 months has been to build cottages and sell shares so that the financial status of the company can be stabilised. This process is going well. But selling shares has not been easy. Suvidha has to keep a note of the competition, which was non-existent 5 years ago. To that end, while not being ostentatious, some form of a 'decent' get up for the estate is a requirement. To meet this goal, the frontage is being developed along with an aesthetically pleasing car park. An office extension is being built with aluminium partitions so that interaction with SH and potential SH can occur in a 'decent' ambience. Finally, when finances permit, the club house has to be completed. The board has chosen the option to harness the demand for car park to raise funds for building the frontage.

#### **Phase 1a progress**

The construction is progressing well. The number of cottages subscribed to stands at 13; there are serious enquiries for 2 more cottages. The board has decided not to build the road from the clubhouse to the cottages. Instead, the approach to cottages on the higher reaches will be to go south on the west side road first, go round a circle to be built around the rock and proceed north on the east side road that will be built only up to the northernmost cottage.

## **Office extension**

It was clarified that there is no need to do anything on the 'sly'; it is within the prerogative of the board to plan and execute these 'jobs' like the office extension, for the good of Suvidha. Details about what is being done was given during the presentation.

## **Covered Car park**

The house was in favour of the present location. Alternative locations have their own drawbacks – like interference with building cottages (if required) on the north-western part of Suvidha or the need to have a full-fledged road on the eastern side of the property if the car park is located on the southern part of Suvidha. Wherever it is built some cottages will end up being far away from the car park.

## **Letter boxes and cycles**

There were a lot of suggestions about the issue of letter boxes; the majority opined that letter boxes, either in the clubhouse or in front of cottages, was not a good idea. If staff are reluctant to use cycles, it was suggested that we could buy electric scooters. The feasibility of this would be explored; the alternative is to insist on the staff using cycles.

## **Fixing Glass Shutters on sit out**

After a fairly heated debate on the issue, the house decided by a majority that such glass shutters are permanent structures and that they cannot be permitted as the 'exterior'/elevation changes contravening the rules laid out in RVM. The MD promised the SH concerned that her issue of insects/reptiles creeping into her sit out will be addressed by some other means.

## **Noisy traffic in Suvidha**

This topic was discussed only in passing; in fact, one of the residents asked for allowing free use of SH owned vehicles to overcome the difficulties in getting a buggy on time. The MD mentioned about the noise even with the present restricted use of own vehicles. He promised to enforce the rule strictly to reduce the noise levels.

## **Allotment of 2 slots in the old car park to the same SH, earlier**

The MD made enquiries about this past event in the office. He was told that 2 slots were given to the same person as the company needed the money at that time. This view was contested by others who mentioned that all the residents were not contacted at that time. The present board had no part to play in these events. The house requested, and the MD agreed, that we would request the concerned SH to consider relinquishing the 2<sup>nd</sup> slot. The house was unanimous that it would be incorrect to stop someone from renting out the slot.

## **Renting of cottages**

The MD clarified that the focus of the company is to sell shares for Phase 1a. The limited office resources cannot be diverted to renting activities. The office facilitates the renting process if the SH find a tenant. The SH are at liberty to advertise on the web, take the help of other SH etc. in renting out their cottages. In all these years only one tenant has gone on to buy a cottage in Suvidha.

## **Housekeeping services**

The house felt that the enforcement of the schedule drawn up for housekeeping was not effective. The MD requested residents to volunteer to supervise these and other activities. Mrs Bharati and Mr Chigateri volunteered to help Mr Reddy to streamline this process.

The MD stated that Mrs Vathsala's letter regarding canteen, buggy services and the garden would be looked into.

Many issues were discussed in 'other matters' as under:

- Mr Jaisim wanted check dams to be put up in various places to try and keep the water within Suvidha. The MD promised to take this further after a one on one discussion with Mr jaisim.
- Many residents complained about a bad smell in the toilets. Residents' suggestions to install gully traps and making venting 'holes' will be undertaken.
- To a question, MD clarified that the issue of installing water meters has been dropped for now. The major use of water is in the common areas and the cost of installing the meters may not be justified.
- Stray dog menace was mentioned. The perimeter compound will be attended to by having a mesh to close gaps in the wall to prevent dogs from entering Suvidha.
- Residents requested first aid training. Dr PMC agreed to arrange 'Basic Life Support' training to the residents.

**How Vaidyanathan.A's year old startup PAQS is helping clean the polluted air**

BENGALURU: Clearing the air in India's polluted metropolises might be a gargantuan task for governments, but an intrepid entrepreneur is showing that he is game for the challenge.

Management graduate Vaidyanathan A is building a set of digital devices that he claims can help to monitor and alleviate the effects of air pollution at public places as well as for individuals. His year-old start-up PAQS, which stands for Personal Air Quality Systems, is using the concept of internet-of-things where machines communicate with each other to build devices that work synchronously with smartphones.



"Using technology as a tool to make individuals more aware, healthier and better is the objective," said Vaidyanathan, an engineer and graduate of the Indian Institute of Management, Bangalore.

With just 280 pollution mapping centres for a population of 1.2 billion and some of the most polluted cities, India is hungry for solutions that can improve air quality.

PAQS aims to target enterprise customers with its device, My Air, which maps surrounding pollution levels, and can be attached anywhere - in office spaces, hospitals, houses or cars. PAQS is in talks with large corporations to use the device on campuses, said Vaidyanathan, who was unwilling to disclose the names of the companies he is negotiating with. He is also working with several medical research institutes and pulmonologists to add more features to a 'smart inhaler' that his company is building.

"We are currently evaluating the product. It is a mobile healthcare (device)," said G Padmanabhan, chairman of the government-run Biotechnology Industry Research Assistance Council, which aims to foster research and entrepreneurship in the biotechnology space. "The (smart inhaler) can navigate and provide pollution data to asthma patients who face unexpected attacks."

The technology-enabled inhaler registers parameters such as body temperature, external temperature, and pollutants in the atmosphere, all of which is controlled by an application on a smartphone. Investors are of the view that the devices need to be validated on two counts - data and scientific assessment.

"The first is easy. If the second is done, then doctors can recommend it to asthma patients," said Ramesh Babu, a cardiologist who is now a partner with the Ventureast Tenet Fund. Cleantech fund Infuse Ventures is also working with PAQS to commercialise the two devices "My Air is something that can be attached in a car, in a house, anywhere, and provide helpful data for individuals and corporations," said Shyam Menon, investment director of Infuse Ventures.

Crowdsourced data and continuous air mapping are the biggest selling points besides cost effectiveness, said Vaidyanathan, who has tested the smart inhaler in seven cities across the world, including Chennai and Bengaluru in India. He has applied for global patents for both products. "The convergence of cleantech, biotech and infotech is exciting. It is technology for a larger cause, and that's what we are here to do," he said.

**Bougainvillea**



The first European to describe these plants was Philibert Commercon, a botanist accompanying French Navy admiral and explorer Louis Antoine Bougainville during his voyage of circumnavigation in 1789. The first European to observe these plants was Jeanne Bare, Commercon's lover and assistant who was an expert in botany; because she was not allowed on ship as a woman, she disguised herself as a man in order to make the journey (and thus became the first woman to circumnavigate the globe).

Through the ensuing years, this Brazilian beauty has assumed its rightful place as one of the most popular, spectacular and beautiful tropical plants. The modern day hybrids of Bougainvillea spectabilis (B. Brasiliensis) and B. glabra are among the most beautiful of flowering vines. These tropical members of the Nyctaginaceae family, are very vigorous, evergreen, woody vines with spines. Although normally climbers, they can be trained to stay bushy as pot plants, hanging baskets, or as standard 3 or 4 feet high. They will bloom beautifully on branches on 18"-20" long.

Keep all long shoots cut back to 18"-20" for best bloom. The vibrant color of this vine comes not from the small white tubular flowers, but from the 3 large paper-like bracts that surround each flower.

The blooms as we know them are not true flowers, but are 3 large papery bracts that encircle small, white, tubular inconspicuous flowers much like the poinsettia.

Many of today's bougainvillea are the result of interbreeding among only three out of the eighteen South American species recognized by botanists. Currently, there are over 300 varieties of bougainvillea around the world. Because many of the hybrids have been crossed over several generations, it is difficult to identify their respective origins. Natural mutations seem to occur spontaneously throughout the world; wherever large numbers of plants are being produced, bud-sports will occur.

Some of the best bougainvilleas to look for in your local garden are: California Gold (golden yellow), Juanita Hatten (dark pink), Barbara Karst (bright red to crimson), Jamaica white and Texas Dawn (pink).

- **Birds of SUVIDHA:** This is a series of beautiful and at times stunning pictures of birds that are either resident of or visitors to our Village. Mr. Ashok Dey, a permanent resident of SUVIDHA since November 2010, has been able to photograph as many as 69 different species of birds in the Village.



**Mottled Wood Owl**



While passing our plant nursery at dusk many walkers have heard a loud, quavering, eerie but yet somewhat pleasant call from near the western boundary wall, which goes something like *chu-hua-*

aa, sometimes followed by a mellow hoot. Both Lakshmi and I knew that it was the call of an owl but it was Sarath Champati (who with his wife Indu has moved into Cottage # 115-A (who recognised the call as that of the **Mottled Wood Owl (*Strix Ocellata*)**). Reading about this bird I learnt that it is mostly nocturnal and crepuscular and keeps to thickly wooded areas. But one morning a few weeks ago, I got very lucky. While waiting under the very large fig tree behind Sarath's cottage I heard the cawing of crows followed by loud rustling sounds.
