
# Report on the 16<sup>th</sup> AGM of the Company

The Annual General Meeting (AGM) of the Company was held on 27.12.2020 and for the first time in the history of Suvidha, this AGM was virtual.

In light of the ongoing COVID pandemic and the directives of the Ministry of Corporate Affairs, which allow companies to hold AGM via Video Conferencing, Suvidha choose the Zoom platform to conduct its AGM. Despite having no previous experience on conducting a virtual general meeting, the board of directors took pains to learn the logistics and meticulously planned and conducted the AGM. Their combined hard work paid off as there was an overwhelming response from the shareholders A record 181 members of the company registered for the event. In other words, 75% of the 241 members whose email IDs are registered with the company registered for the AGM. Approximately 130-140 members attended the 3-hour long AGM.

In addition to reports on the activities in the past year, all questions received by email and questions by attending members who had been already cleared to ask them during the AGM, were taken up one by one and dealt with satisfactorily.

For the first time, polling on the resolutions was conducted via email ballots. Again, there was enthusiastic participation of members in the voting process. Out of 186 registered members, 161 members (i.e. 86% of those eligible to vote) cast their votes through e-mail, making this the highest direct participation by members of Suvidha.




A few days after the AGM the company sent out a survey to get feedback of the members and obtained 78 responses, 81% of them residing in India and 15% in the U.S. and 87% from those who attended the AGM. Out of 70 respondents who attended the AGM, 80% rated the meeting as Very Good or Good.


Also, 80% of the members who took part in the survey recommended that future AGMs be held by VC/OAVM.

97% of those surveyed said they received the email ballot – others were joint shareholders The email voting experience was rated as either easy or very easy by 81% of those who voted.



Also, 76% of those surveyed recommend email voting process for future AGMs if allowed by MCA.

#### Welcoming the New Year at Suvidha 01/01/2021



#### DR. VIVEKANANDA SIDDIAH





#### How Suvidha dealt with the Pandemic

Quarantine measures have been strictly followed in Suvidha for residents, visitors, or staff members. Several incidents, some funny and some sad happened in the early days in our alacrity to follow the BBMP advice. And then two residents tested positive to Covid 19 one after the other. Fortunately, the first person recovered fairly quickly without needing ICU admission and returned to quarantine and wellness soon after. The second case was of a resident with chronic chest condition who tested positive and was shifted to a Covid Care Hospital. He too recovered thanks to the tireless and dedicated care of his family members


Covid trouble occured again when a resident breathed his last in November and the relatives had to wait for the BBMP officials to come and collect the sample at 9 pm and give the Covid negative report before funeral arrangements could be made for the next day. For another resident leaving Suvidha for good to stay abroad, the Covid negative report came only a few hours before her departure leading to much heartburn for everyone concerned.

Within the Village we have display boards to use masks and practise social distancing norms, make use of hand sanitiser stands, gloves, and electronic thermometers when we return from outside. Many of us have purchased digital thermometers, electronic BP apparatus and pulse oximeters. The Health Centre is equipped with an Oxygen Concentrator to provide oxygen

continuously for the needy without being dependent on the bulky oxygen cylinders that need to be refilled.


We in Suvidha never let down our guards and continue to follow the prescribed guidelines for protection from Covid 19. We are grateful to all the people working round the clock towards keeping us safe.

Currently there is concern about the new variant of Covid 19 from the UK coming into Bangalore. But we believe that if we continue to be vigilant we will all be safe here in Suvidha.

Scorching hot summers that bring in the rains


