September 22, 2024

■ he Twentieth Annual General Meeting of **SUVIDHA** shareholders took place on September 22, 2024, via Zoom virtual platform. Dr. Nilima Kadambi was the Chairperson of the meeting. The entire meeting was for the duration of about an hour and a half.

The Company Secretary and Dr. Nilima Kadambi took us all through the proceedings in an orderly manner. All

relevant topics were discussed. The excellent tech support ensured that the meeting progressed well without any glitches. A day later, the results of the AGM voting of resolutions were published. The shareolders appointed three new directrs, Mr MN Kannan, Mr Suresh Babu and Mr

> Chandrakant Bhatt (Independent Director) to the Suvidha Board of Directors. However, due to some unexpected and unavoidable family circumstances, Mr. MN Kannan resigned from the Board on September 26, 2024 and his resignation was accepted by the Board on September 30, 2024. Currently, there are nine Directors on the Suvidha Board.

### Chandrakant Bhat

handrakant Bhat, 65, has been approved by the shareholders to be one of the Independent Directors in the Board of Directors of SUVIDHA. He

resides in Cottage 85 and is an Australian citizen with OCI status in India. He has a Diploma in Man-made Textile Technology from SASMIRA, Worli, Bombay, and an Advanced Diploma in Customs Agency Practice from the Sydney Institute of Technology, Petersham campus. He secured first rank in the State of NSW and was the recipient of the Butterworths prize 1998. He also secured distinction in every subject that included Commercial Law with particular emphasis on Company Law, Accounting, Marketing, Tariff and Valuation etc.

He worked for two years with International Conveyors, Aurangabad, and two years with Goodyear India, Ballabgarh, Harvana. After moving to Australia he worked for two years with S&L Rubber Company, Alexandria, Sydney,

two years with Computer Resources Company, Davies Road, Padstow, Sydney and then 25 years with Australian Customs and Border Protection. He

retired from service 10 years ago and has been a resident of SUVIDHA since October 14, 2014.

"Apart from the above I was Chairperson of the Executive Committee of Harrow Pines, a 220 villa and townhouse Strata Title complex in Glenfield, Sydney for 15 of the 17 vears I resided there between the years 1996 to 2013. This was a complex not unlike SUVIDHA, except that Harrow Pines was governed by the Strata titles act. I was also a Director with the Theosophical Society, Kent Street, Sydney for 5 of the 10 years between the years 2003 to 2013. Out of the 25 years or so I was with Australian Customs at Sydney Kingston

Smith Airport, I was the Harassment contact officer appointed under the Occupational Health and Safety Act," informs Chandrakant Bhat.

# **Outsourcing of Kitchen Services**


October 10, 2024



# **Dengue - Awareness and Protection**

August 7, 2024

r Sunil and Vaishnavi from Bridge Health spoke about the disease dengue and how it affects human bodies. When people contact it via an infected mosquito, they

mosquitoes at home, we have to be careful to see that there is no stagnant water around our homes, keep our surroundings clean and use nets, mosquito repellents, etc.

The Health department should be approached to help clean the surroundings for the community,



have to drink plenty of liquids, and have paracetamol. If weakness persists, they have to be hospitalised. To control the infestation of

close open drains, and ensure there is no stagnant water. They should also provide fogging services

#### **Dengue - Signs and Symptoms**

Typically, people infected with dengue virus are asymptomatic (80%) or have only mild symptoms such as an uncomplicated fever. Others have more severe illness (5%), and in a small proportion it is life-threatening. The incubation period (time between exposure and onset of symptoms) ranges from 3 to 14 days, but most often it is 4 to 7 days.

The characteristic symptoms of mild dengue are sudden-onset fever, headache (typically located behind the eyes), muscle and joint pains, nausea, vomiting, swollen glands and a rash. If this progresses to severe dengue the symptoms are severe abdominal pain, persistent vomiting, rapid breathing, bleeding gums or

nose, fatigue, restlessness, blood in vomit or stool, extreme thirst, pale and cold skin, and feelings of weakness. In a small proportion of cases, the disease develops into severe dengue with bleeding, low levels of blood platelets, blood plasma leakage, and dangerously low blood pressure.

Dengue virus has four confirmed serotypes; infection with one type usually gives lifelong immunity to that type, but only short-term immunity to the others. Subsequent infection with a different type increases the risk of severe complications. The symptoms of dengue resemble many other diseases including malaria, influenza, and Zika. Blood tests are available to confirm the diagnosis including detecting viral RNA, or antibodies to the virus.

# **Masterclass on Hearing Health**

September 28, 2024

ravinda HR, Senior Audiologist spoke for 30 minutes on hearing health to Suvidha residents at the Banquet Hall. This was followed by free audiometry screening and free fine tuning of hearing aids, with the offer of exclusive upgrade options.





## Hearing Loss - Signs and Symptoms

- \* Difficulty using the telephone
- \* Loss of sound localization
- \* Difficulty understanding speech, especially of children and women whose voices are of a higher frequency.
- \* Difficulty understanding speech in the presence of background noise (cocktail party effect)
- \* Sounds or speech sounding dull, muffled or attenuated
- \* Need for increased volume on television, radio, music

and other audio sources

It is estimated that half of cases of hearing loss are preventable. Avoiding exposure to loud noise can help prevent noise-induced hearing loss. 18% of adults exposed to loud noise at work for five years or more report hearing loss in both ears as compared to 5.5% of adults who were not exposed to loud noise at work.

# **Our memories of Ethiopia**

thiopia, in the Horn of Africa, is a poor. warring nation, rich in ancient culture, with warm friendly people, and is a great place for travel. Sriram and I went there, in the time of their Christmas and Epiphany, in Jan.-Feb. 2023. Sriram taught in the Intensive Care Department of their largest hospital, in Addis

#### Ababa.

Ethiopia has never been colonised, except for a brief occupation by Italy during WWII. The last Emperor, Haile Selassie, was murdered in the Communist takeover, in 1974, during which 1.2 millions died of famine, (remember Bob Geldof?) and 7 lacs were killed for their politics. 1 million of the richer people emigrated.

Now, with a "paper" democracy, there are still civil wars, great poverty, but, also, economic,

health, and educational progress, to which India and China contribute significantly.

Christianity reached here directly from Palestine, in the 4th century. It is an Orthodox church, with services in an ancient language called Ge'ez. One third of the populace is Muslim. The country comprises about a dozen regions. formerly ruled by warlords, speaking different languages, and often at

loggerheads, even to this day. You had to trace your ancestry to King Solomon and the Queen of Sheba, to be able to rule the states!

Ethiopia was one of the founding states of the African Union. Some tribes produce the finest long

distance runners in the world. Some blacks in Jamaica and elsewhere, belong to the Rastafarians, a cult that worships Haile Sellasie as God, him being the only African ruler not defeated by Europeans. A surprising fact is that the weather here is cool throughout the year, since it is high on a plateau. The plateau also draws in the monsoons and feeds the Blue Nile, causing the annual

# Kodanad Elephant Sanctuary

y grandparents had cooked up an ingenious plan to get me to do lessons. I'm generally quite lazy in this department, preferring to do the

barest minimum I can get away with, and they had probably noticed this sad state of affairs. So they came up with a genius plan.

When they arrived to pick me up from my home, my grandmother informed me that if I was a good girl and I did lessons every day, they would take E me to Kodanad

Elephant Training Camp. Wow! Talk about the carrot on a string! Accordingly, I laboured for eight hard days and managed to pull through, but the

reward was excellent, because my grandparents kept their word and took me to the training camp.

The parking lot was bare earth, and there was a lone dog slumbering in the middle of it — quite an

anticlimactic entrance to a wildlife park. We got out and went to buy tickets at the ticket counter. where I was shocked to learn that the charge for foreigners was six times that of an Indian adult but no matter, as even this exorbitant sum could be matched by an average American kid's pocket money.

Having secured our tickets, we proceeded through the Butterfly Garden. We unfortunately did not spot any butterflies, but there were boards advertising the

specimens we could have seen if we had come at the right time. The flowers were beautiful, anyway.

We decided to stop at the Deer Park first. There were four enclosures, all made of bare earth with grass, trees, and watering holes, and, of course, deer. In two enclosures were big herds of spotted deer — small, graceful creatures with white-spotted reddish fawn coats. They looked tiny from a distance, and yet it was deceptive: the stags had

tall, sweeping antlers that no sane person would wish to go anywhere near. They regarded us with startled dewy eyes before apparently deciding we weren't worthy of their attention and going back to their business.

Unlike their relatives the spotted deer, the sambar had no pretense toward delicacy. Big. muscly, and heavyset, they moved like tanks around

their two enclosures, glaring at us for a few minutes before again ignoring us. One enclosure was for stags and does, the other for only does.

We continued on to the star attraction, the kraals themselves. After a short walk, we found ourselves watching a young elephant being bathed and enjoying it. She was lying down as her mahout scrambled over and around her,

alternately hosing her with water and scrubbing her with a scrubber, giving her commands in Malayalam as he worked. "Roll over!" "Lift your trunk!" At one point, he commanded her to greet us, and she did, raising her trunk and waving.

We watched this elephant for a while, then moved on to the others. There was Aasha in her tall kraal, moodily savaging a bushel of jack-fruit leaves and Abhimanyu, squat and muscled, set apart from the other kraals; to name just a couple. Peelandi

Chandru was a little further down the path, but in my opinion he was the most unique of all the elephants. He was tearing up the trunk of some unlucky tree and crushing the pieces in his mouth with a sound unnervingly like that of a tiger crushing a bone. A piece of the trunk would keep getting stuck between his tusk and his trunk, and he would watch us without seeming to until we laughed, upon which he would extract the stuck piece and crunch it up.

After we had goggled at all of the elephants, we found a tree house. First I cautiously climbed up, and then my grandparents followed. (I'm sure they've won a Guinness World Record for First Grandparents To Climb A 10 Feet High Tree House.) We enjoyed the view and clicked some photos, but before long a pack of bloodthirsty mosquitoes discovered us and chased us back to the ground.

We enjoyed some refreshment and I swung around in the playground (which really has an overdose of swings), then bid farewell to Parvathy. She greeted us a second time without anyone telling her, so maybe she liked us.

Then we jumped back in the car and visited the birthplace of Adi Shankara — but that's a story for

another time.

was the traditional Ganapati Aarthi, "Sukha Karata - Dukha Harata." This aarthi, symbolizing the removal of obstacles and the granting of happiness, was a fitting conclusion to the

sense of togetherness and gratitude and made it yet another memorable and meaningful celebration.

### History of Ganesha Chathurthi

The earliest mention of Ganapati is found in the Rigveda where it appears twice, once in shloka 2.23.1, and in shloka 10.112.9. Both of these shlokas imply a role of Ganapati as "the seer among the seers, abounding beyond measure in food presiding among the elders and being the lord of an invocation", while the shloka in mandala 10 states that without Ganapati "nothing nearby or afar is performed without you". However, it is uncertain that the Vedic term Ganapati which literally means "guardian of the multitudes", referred specifically to later era Ganesh, nor do the Vedic texts mention Ganesh Chaturthi. It appears in post-Vedic texts such as the Grhya Sutras and thereafter ancient Sanskrit texts such as the Vaiasanevi Samhita, the Yainavalkva Smriti and the Mahabharata mention Ganapati as Ganesvaras and Vinayak. Ganesh appears in the medieval Puranas in the form of "god of success, obstacle remover". The Skanda Purana, Narada Purana and the Brahma Vaivarta Purana,

in particular, profusely praise him. Beyond textual interpretations, archaeological and epigraphical evidence suggest Ganesha had become popular, was revered before the 8th century CE and numerous images of him are traceable to the 7th century or earlier.

Although it is unknown when Ganesh Chaturthi was first observed, the festival has been publicly celebrated in Pune since the era of King Shivaji (1630–1680, founder of the Maratha Empire). The Peshwa in the 18th century were devotees of Ganesha and started as a public Ganesh festival in their capital city of Pune during the month of Bhadrapad. After the start of the British Raj, the Ganesh festival lost state patronage and became a private family celebration in Maharashtra until its revival by Indian freedom fighter and social reformer Lokmanya Tilak, who, championed it as a means to circumvent the colonial British government ban on Hindu gatherings through its anti-public assembly legislation in 1892.
